CSIR – Central Food Technological Research Institute, Mysuru a constituent national laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of 1 (One) position of Project Assistant Level II initially for a period of one year or till the project is over on a temporary contractual basis in the DST funded Project entitled **“Profiling and Functional Characterization of Rice Bran Lipases, a Comprehensive Data for Rice Bran Lipid Metabolizing Enzymes” (GAP-0484)** at the Lipid Science Department CSIR-CFTRI, Mysuru, Karnataka.

**Essential Qualifications:**

First class M.Sc./M.Tech. in Biochemistry / Biotechnology / Molecular Biology / Life Sciences / Bioinformatics with good academic records.

**Desirable:** Experience in lipid metabolism, molecular biology, animal cell culture and bioinformatics.
