Essential Qualifications:

First class B.Sc. in Biology / Botany / Chemistry / Physics / Computer Science/ Zoology/ Microbiology / Biotechnology or an area related to Life Sciences.

Emoluments:

1. Candidates should not have exceeded **25 years** of age as on **07.03.2017** i.e. the last date of receiving the applications. Age relaxation as applicable by Gov. of India rules for SC/ST/OBC and women candidates will be considered.

3. The engagement will be contractual and on purely temporary basis for a maximum period of one year or co-terminus with the project, whichever is earlier.
