CSIR – Central Food Technological Research Institute, Mysuru a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of 1 (One) position of Junior Research Fellow initially for a period of one year or till the project is over on a temporary contractual basis in the project entitled “**Starter Culture Technology for Processing Quality Coffee**” (GAP-0508) funded by SERB, New Delhi, tenable at the Department of Spices and Flavour Science, CSIR-CFTRI, Mysuru, Karnataka.

Essential Qualifications:

First class M.Tech. in Biotechnology/Biochemical Engineering/Technology with good academic records or First class B.Tech. in Biotechnology/Biochemical Engineering/Chemical Engineering/Technology should have qualified GATE or equivalent exam with good academic records. Or Post graduate in basic science with NET qualification (desirable biotechnology/Microbiology/Food technology)

Emoluments:

Rs.25,000/- per month (Rupees Twenty Five Thousand only) consolidated for I & II year and Rs.28,000/- per month (Rupees Twenty Eight Thousand only) consolidated for III & IV year .

Terms and Conditions:

1. Candidates should not have exceeded **28** years of age as on **24.03.2017** i.e. the last date of receiving the applications. Age relaxation as applicable by Gov. of India rules for SC/ST/OBC and women candidates will be considered.
2. The engagement of JRF is exclusively for the above mentioned research work.
3. The engagement will be contractual and on purely temporary basis for a maximum period of one year or co-terminus with the project, whichever is earlier.
