CSIR – Central Food Technological Research Institute, Mysore a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of **2 (Two) positions of Project Assistants (Level-II)** initially for a period of One year or till the project is over on a temporary contractual basis in the **Fast Track Translation project** entitled **“Know-how of the isolation of arabinoxylans from defatted cereal brans”, (MLP-0202)** at the Department of Biochemistry CSIR-CFTRI, Mysore, Karnataka.

**Essential Qualifications:**

First class M.Sc. in Biochemistry/Plant Biotechnology/Bioscience/Food Science and Nutrition with good academic credentials.

**Desirable experience:** One year experience in the isolation and characterization of Biomolecules such as carbohydrates/proteins and lipids.
